Footnotes: (1) The various ticker symbols for each fund are for different classes of shares. (2) OEF=open-end fund; CEF=closed-end fund; ETF=exchange traded fund; ETN= exchange traded note. (3) MLP funds primarily invest in MLPs. MLP-Related (MLP-R) Funds include MLPs in a mix of investments. (4) Primarily MLP GPs. (5) If a fund qualifies as a RIC (MLPs must be < 25% of fund assets) it pays no corporate tax as long as earnings are distributed. Otherwise it is treated as a C-corporation and must pay corporate tax. This does not apply to ETNs, which are not subject to corporate tax.
